Sealed Quotations are re-invited from the empanelled vendors of DPCC, Govt. of NCT of Delhi for disposal of scrap of e-waste of this office. The description of the e-waste is given below:-

2. **Schedule of tender:**

Period of issuance of quotation : from 14/11/2016 to 02/12/2016 between
02:00 pm to 04:00 pm.
Date and time for submission of quotation : on 05/12/2016 from 11:00 am to 03:00 pm
Date and time of opening of the quotation : on 05/12/2016 at 3:30 pm onwards

3. **Scope of the work**

Lifting & proper disposal of the e-waste (obsolete photocopier machine, mentioned above) as per the guidelines issued by Ministry of Environment, Govt. of India at their own cost. The e-waste shall be provided to bidder on ***as is where is basis***.

4. **The terms and condition**

The interested & empanelled vendors of DPCC, Govt. of NCT of Delhi are required to submit along with the bid, the following documents:-

- (i) An Earnest Money Deposit (EMD) of Rs.1,000/- (Rupees one thousand only) in form of Pay Order/Demand draft/Fixed Deposit Receipt (only) of a scheduled Bank in favour of ***Drawing and Disbursing Officer, Principal Accounts Office, A-Block, Vikas Bhawan, Govt. of NCT of Delhi***. The EMD, in cash or through cheque shall not be accepted due to administrative reasons.
- (ii) Valid certificate or Consent Order, issued by Delhi Pollution Control Committee (DPCC), Govt. of NCT of Delhi in respect of bidder.
- (iii) The bid/Rate should be submitted in the prescribed manner i.e. per Kilogram of e_waste and as per prescribed Performa, mentioned hereinafter. The rate should be in Indian Rupees. The bid submitted in any other form or on other loose paper

shall liable to be rejected. The conditional bid is also liable to be rejected. Bid/Quotation submitted without EMD or requisite valid certificate of DPCC will also be summarily rejected.

- (iv) The bid received after stipulated time & date shall be rejected out rightly. No document, after submission of bid, will be considered. Hence, bidders are requested to ensure that all necessary documents should be enclosed with the bid well in advance i.e. while submitting bid.

5. The bid should be submitted in a sealed cover. Normally, the bidder quoted highest rate will be eligible for award of the work after being declared as successful bidder. However, Head of Department of Principal Accounts Office, Govt. of NCT of Delhi, Delhi does not bind himself to accept the highest bid. The Department reserves rights to annul the whole tendering process or reject any or all the quotations without assigning any reason at any point of time. The decision of Controller of Accounts/Head of Department, Principal Accounts Office, Govt. of NCT of Delhi shall be final and binding in this regard.

6. The letter of Acceptance (LOA) shall be issued in respect of successful bidder after assessment of all bids. The work award letter shall be issued after receipt of full amount of bid in form of demand draft of any scheduled Bank in favour of **Drawing and Disbursing Officer, Principal Accounts Office**, A-Block, Vikas Bhawan, Govt. of NCT of Delhi from the successful bidder within 03 days of the issue of LOA. Failing to deposit entire due amount of bid by the successful bidder within stipulated time shall entail to forfeiture of his EMD in full without prejudice to the other rights and remedy available to the Govt. against the bidder. The successful bidder has to lift the e-waste within 15 days from the date of issue of work award letter. Further, in case the successful bidder fails to lift the e-waste within time stipulated, his EMD/security money shall liable to forfeit alongwith other sums/deposit and the bidder shall be disallowed to take the e-waste. However, as an exception to this condition, the successful bidder shall be allowed to lift the e-waste within 07 days after the time stipulated only with payment of additional charges of Rs.500/- for each day of delay on the sole discretion of Controller of Accounts, Principal Accounts Office, GNCTD.

7. A certificate to the effect that the e-waste lifted from this office has not been resold in its original form but to be dismantled only is to be furnished by the successful bidder. The EMD of successful bidder shall become the performance security and will be released only after providing the above certificate. The EMD of unsuccessful bidder(s) shall be refunded after finalization of financial bids.

8. The bid submitted shall remain valid for acceptance for a period of 120 days from the date of bidding. After submission of bid, it is not permissible to withdraw the bid by any of the bidder. In case any bidder withdraws or modify his bid during the intervening period of acceptance, his EMD shall be forfeited and his quotation shall stand cancelled for all purposes. No correspondence in this regard shall be entertained.

9. All the disputes are within the jurisdiction of Delhi.

10. Interested parties may visit the Location as mentioned above on any working day between 2:00 pm to 04:00 pm.
